Smart Center Guidelines

Please review the following Smart Center guidelines and sign that you (guardian and child) understand and will abide by them.

- Smart Center is a resource for students to benefit from extra help in studying and completing assignments. Anyone in Smart Center who becomes a distraction to others will be asked to leave.
- Unless a student is seeing a teacher, he/she should come straight to Smart Center immediately after school. If a student is seeing a teacher, he/she must get a signed pass from that teacher with the date and time when finished and then come straight to Smart Center.
- Students are not permitted to go anywhere else before coming to Smart Center. Students who come late (after 2:55) without a note will be considered out of area and sent to administration.
- Any location other than a teacher's classroom or the Smart Center is considered "out of area." Students out of area will receive a referral.
- Cell phone use is allowed in Smart Center FOR EDUCATIONAL PURPOSES and GUARDIAN COMMUNICATION **only**. Cell phone use that creates a distraction for any student, including the phone's owner, will result in the phone being confiscated and given to GTCHS administration for pick up by a guardian the following day.
- Laptops or Chromebooks are available for academic use only. Students may sign out computers for educational purposes. No food or drink is allowed while using the laptops.
- To ensure the safety of students, we request that parents call the Smart Center at **864-672-3798** when they arrive to pick up students. Students are not allowed to leave the Smart Center until their rides have arrived. Students who are driving must leave campus immediately after leaving the Smart Center. Some Fridays, Smart Center is held in an alternate location and that phone number will be provided to you.
- Smart Center students are to be in GTCHS dress code at all times.
- Students who do not abide by these guidelines will not be allowed to attend Smart Center and will not be refunded their membership fee.
- There is a **\$1 per minute charge** for late pickup (after 5:45). Late parents will be invoiced and the school will pay the tutor for their time.
